Mr. Knibbs has also been appointed as a Special Assistant State's Attorney several times, representing Cook County elected officials and agencies in state and federal court. Mr. Knibbs has also conducted independent investigations on behalf of *Fortune 100* companies, educational institutions and governmental entities.
