In the Probate Division, he was sought after by lawyers and their clients to mediate pending litigation, including in cases that were not on his call. He completed mediation training at the National Judicial College.

While Judge Fleming has extensive experience mediating all facets of probate matters, including estate, trust and guardianship issues, he is also qualified to mediate contract, commercial, business and other civil matters. Judge Fleming is a certified mediator in the mediation programs for the Circuit Court of Cook County Law, Chancery and Probate Divisions. He is a frequent presenter at the IICLE on probate mediation.
